### Agency Agreement

The following are the terms and conditions of participating in the UniversalBusinessListing.org Agency Program.

"Agency" refers to yourself or your Company ( \_\_\_\_\_ located at

### Payments and Commissions

UniversalBusinessListing.org will bill Agency \$20 per listing per year, which is \$10 off the UBL market rate of \$30 based on 100 annual listing minimum. The Agency will send listings by bulk file to UBL which will invoice Agency monthly on new or renewed submissions. Agency will bill and maintain customer accounts itself.

Invoices are due upon receipt. UniversalBusinessListing.org will request payments in advance until such time as positive credit history has been developed. The standard period for this history to be established is 100 listings.

Although the Agency Program is not limited to the U.S. all payments will be made in U.S. dollars. There are no refunds available as UBL will be processing immediately upon receipt of the listings from Agency.

All Agencies are NOT employees of UniversalBusinessListing.org and are responsible for their own local, state, or country taxes. All Agency applications are subject to approval by UniversalBusinessListing.Org.

Both UniversalBusinessListing.org and the Agency reserve the right to terminate this agreement at any time. If canceled, outstanding invoices must be paid immediately.

Agency will be issued a "template" spreadsheet format in which to enter listing data for bulk delivery to UBL, or will be provided with an API. This template may change from time to time according to industry or other requirements.

UniversalBusinessListing.org reserves all rights in or to its trademarks and service marks but may be used by Agency in accordance with this agreement. The UBL trademark may not be used to register internet domain names for any purpose. Agency may in no way display a UniversalBusinessListing.org logo, image, or trademark which may be distasteful, defame, or misrepresent.

Agency shall not misrepresent UniversalBusinessListing.org products or services.

UBL will offer guidelines for listing profiles to be successfully published but in no way guarantees acceptance by any publisher. Agency is solely responsible for insuring that their listing data is appropriate to be submitted to UBL distribution sites.

Agency agrees to not send unsolicited mail or SPAM mail to promote any of UniversalBusinessListing.org products or services. This action WILL RESULT in immediate termination of your account with a cancellation of any pending commissions. Agency will also be in violation of the UniversalBusinessListing.org Agency Agreement and subject to legal action.

**Prohibited Sites:** Sites that promote sexually explicit material or violence do not qualify as an Agency. Sites that promote discrimination based on race, sex, religion, national origin, and physical disability, shall not be accepted. Sites that promote illegal activities shall not be accepted.
